Dear Valued Lantronix Customer,

Lantronix is pleased to announce the launch of RoHS compliant versions of XPress-DR products that will replace the existing versions of the XPress-DR. This action is necessary to be in compliance with upcoming (July 2006) RoHS regulatory requirements.

The current (non-RoHS) versions of the XPress-DR products will be discontinued as explained further in this notice. There was no design change made to the XPress-DR products, only conversion to RoHS compliant raw materials. The new XPress-DR RoHS versions are form-fit-function the same as the existing XPress-DR products. For quality and tracking purposes, Lantronix is changing the part numbers as follows:

Feature/Enhancement	RoHS Description
RoHS-Compliance	Mandated by the European Parliament and Council of the European Union, RoHS (Restriction on Hazardous Substances) requires that manufacturers reduce the usage of hazardous substances including lead, mercury, cadmium, hexavalent chromium, polybrominated biphenyls, or polybrominated diphenyl in electrical and electronic equipment by July 2006.
